### 6. COMMITTEE REPORTS

Committee Chairpersons Selected

Policy / Academic – Mrs. Quigan; Legislative – informational committee, no chair needed; Building / Facilities – Mr. Schoder; Employee Relations - Mr. Gabriels; Audit - Mr. Murphy; Hospitality - shared duties; Ad-hoc - Mrs. Quigan, Mr. Schoder - This committee will review, with the help of selected staff and students, the Basic School Philosophy and Mission Statement.

#### B. Administrative

- 1) Learning Focus Conference presentation Mr. Switzer spoke about the conference he and other staff attended this summer and how the program will be implemented at BCS. Mrs. Seamans and Mrs. Quigan praised the program that is in use at Queensbury High School.
- 2) Mr. Ciccarelli reported that all programs have been retained for the upcoming school year. The biggest change is adding a 26-minute activity period in the daily schedule to allow for AIS, extra-help time, class meetings, as well as extra and co-curricular meetings without interrupting classes.

#### 7. INSTRUCTIONAL PROGRAM

A. Mr. Wilk presented a recommendation from the Committee on Special Education and answered a question from Mrs. Quigan.

- B. Mr. Showers explained how the Power School system works and how it helps with reporting to the Data Warehouse, the statewide student information storage facility. Mr. Switzer spoke about what the student performance data means to our students, classroom teachers, and administrators.
- C. Basic School Philosophy The Ad-hoc committee will be reviewing this.
- D. Athletic Eligibility review The policy committee will review this after discussion with athletic director and coaches.

- E. Annual District Goals and Objectives discussion Mrs. Quigan believes that teachers should have input into developing goals. Mr. Gabriels explained that the Board did discuss the goals with the Teachers' Association last year through the Labor Relations Committee. Mr. Murphy pointed out that NYSSBA offers workshops to help develop goals. Mr. Schoder thought that the Goals should be set after a Mission Statement and School Philosophy were developed. Mr. Ciccarelli suggested that the board may look into developing two separate sets of goals - District and Building. (Mrs. VanAuken left the meeting at 8:18 PM) Mr. Gabriels suggested that consequences of low enrollment should be included. Mr. Murphy requested that the superintendent report how goals have been met in the past and suggested that the new objectives be simple. Mr. Gabriels asked about a timeline. Mr. Schoder hoped to have things in place by October. Mr. Ciccarelli suggested that the board remove time barriers and acknowledge that it's a time of transition. This item will be placed under committee reports each month until completed.
- F. MOTION by Mrs. Quigan, seconded by Mrs. Peterson that the Board of Education continue to allow eligible district students in Grade 12, who will receive a local high school diploma, to receive a passing status on grades in the scoring range of 55-64 in accordance with Commissioner's Regulations for Regent Exam credit during the 2010-2011 school year.

## 8. SCHOOL DISTRICT BUSINESS

A. Smack Appt. District Clerk A. **MOTION** by Mr. Murphy, seconded by Mrs. Qugian that the Board of Education adopt the following resolution:

WHEREAS the Bolton Central School District Board of Education had previously purported to combine, in their appointing resolutions, the title and compensation of the positions of Secretary to the Superintendent, as defined by the Warren County Bureau of Civil Service, with the title and compensation of the District Clerk, as Board Officer who is appointed annually; and

WHEREAS the Board of Education now wishes to correct and clarify its resolutions with respect to the job titles and associated compensation.

NOW THEREFORE, BE IT RESOLVED that the job titles and associated compensation are separate according to the law, and it was further,

RESOLVED, that Angelia M. Smack, based upon Board of Education resolution dated December 8, 1997, occupies the Civil Service position of Secretary to the Superintendent. A document stipulating salary, benefits, terms and work conditions will be delivered to her in revised form, and it was further

RESOLVED, that Angelia M. Smack has been appointed District Clerk annually since the year 1986 and her stipend as District Clerk should have been stated separately, and it was further

RESOLVED, that the motion by Mr. Murphy, seconded by Mrs. Quigan, pertaining to Item 7A — Appointment of the District Clerk, at the Organizational Meeting of the Bolton Central School District Board of Education held on July 12, 2010, is hereby withdrawn and therefore rescinded, and it was further

RESOLVED, that Angelia M. Smack be, and she hereby is, appointed as a Board Officer in the term position of District Clerk for the 2010-2011 school year (July 1, 2010— June 30, 2011). Remuneration for this position for the term expressed shall be \$3,878. Job description and duties shall be those which are stated by New York State Education Law.
