- C. Albany Business Review Schools Report Presentation This year Bolton Central School District's rank rose from 12<sup>th</sup> to 7th among the top 92 ranked schools. Across the board, Bolton Central School's students' performance, from elementary Common Core exams to high school regents, ranked in the top 10 of the region. In Math, BCS students ranked 7<sup>th</sup> and in English, BCS students ranked 4<sup>th</sup>. We are proud of the achievements of our students and look forward to sharing their bright future with our community. The District was not ranked at the high school level due to having less than 20 students take the SAT exam. Our elementary program moved to 16<sup>th</sup> place. Mrs. Pfau thanked faculty and staff for their ongoing dedication to students.
- D. New York State Assessments and Regents Exams Mr. Shippee reported that New York State has not released the scores yet. There should be a report at the September meeting.

D. Presentation of Capital Project Progress.

Mr. Graney, Mr. Shippee reported on various aspects of the project.

Based on community feedback through the results of the March 8, 2017 Referendum Vote, the district made changes to the proposal. Portions of the scope were revised without significantly altering the integrity of the project as a whole. The first goal was to reduce cost. The amount to be bonded has been reduced by approximately \$525,000 dollars. One significant change was the addition of a green roof option to the proposed auditorium which will/should?? some storm water management issues. The project is still

designed to alleviate educational space constraints to allow the District to provide career based experiences in STEAM to our students.

There has been further discussion and there will be further research of a fee structure for public and private use of the proposed auditorium. The District has researched several fee structures from districts within our BOCES for comparison and will be reaching out to other performance spaces to learn more about common practice. The estimated operating costs of the proposed space are estimated to be less than a dollar per square foot per year.

E. **MOTION** by Mrs. Beebe, seconded by Mrs. Johnson, that BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BOLTON CENTRAL SCHOOL DISTRICT (the "School District") that a special meeting of the qualified voters of the School District be and the same is hereby called to be held in the lobby of the Bolton School, 26 Horicon Avenue, Bolton Landing, New York on Tuesday, October 24th, 2017 from 12:00 noon until 8:00 p.m. prevailing time for the purpose of voting on the following proposition:

SHALL the Board of Education be authorized to (1) construct additions to and reconstruct various District buildings, construct a maintenance building, perform site work, acquire original furnishings, equipment, machinery or apparatus required for the purpose for which such buildings are to be used and pay incidental costs related thereto, at a maximum cost of \$8,780,000, (2) expend such sum for such purpose, including the expenditure of \$610,750 from a donation/endowment, \$1,121,750 of fund balance and \$324,500 of capital funds, (3) levy the necessary tax therefore, taking into account state aid and the amount expended from available funds, to be levied and collected in annual installments in such years and in such amounts as may be determined by the Board of Education, and (4) in anticipation of the collection of such tax, issue bonds and notes of the District at one time or from time to time in the principal amount not to exceed \$6,723,000, and levy a tax to pay the interest on said obligations when due?

The vote upon such proposition shall be by ballot registered upon voting machines. The hours during which the polls shall be kept open shall be from 12:00 noon to 8:00 p.m. prevailing time or for as long thereafter as necessary to enable qualified voters who are in the polling place at 8:00 p.m. to cast their ballots.

Personal registration of voters is required either pursuant to Section 2014 of the Education Law or Article 5 of the Election Law and no person shall vote whose name does not appear on the register of the School District. If a voter has heretofore registered pursuant to Section 2014 of the Education Law and has voted at an annual or special district meeting within the last four (4) calendar years, he or she is eligible to vote at this meeting; if a voter

is registered and eligible to vote under Article 5 of the Election Law, he or she is also eligible to vote at this meeting. All other persons who wish to vote must register.

The Board of Registration shall meet in the Main Office of the School District, 26 Horicon Avenue, Bolton Landing, on Tuesday, October 10, 2017 from 8:00 a.m. until 3:00 p.m., prevailing time, to prepare the register of voters of the School District. Any person who has not currently registered under the permanent personal registration by the last date found on such registers or list furnished by the board of elections, and has not voted at an intervening election, must, in order to be entitled to vote, present himself personally for registration. The register prepared by the Board of Registration shall be filed in the office of the District Clerk, 26 Horicon Avenue, Bolton Landing, New York and will be open for inspection immediately upon its completion by any qualified voter of the School District during regular office hours on each business day until the date of the vote.

Absentee ballots may be applied for at the office of the School District Clerk. Applications for absentee ballots must be received by the School District Clerk at least seven days prior to the vote if the ballot is to be mailed to the voter, or on or prior to Monday, October 23rd, 2017, if the ballot is to be delivered personally to the voter. Absentee ballots must be received by the School District Clerk not later than 5:00 p.m. on Tuesday, October 24th, 2017. A list of all persons to whom absentee ballots shall have been issued will be available in the office of the School District Clerk from 8:00 a.m. until 3:00 p.m. prevailing time on each of the five days school is in session prior to the day of the election. Any qualified voter may challenge the acceptance of the ballot of any person on such list, by making his challenge and reasons therefor known to the Inspector of Election before the close of the polls.

BE IT FURTHER RESOLVED, that the District Clerk is hereby authorized and directed to publish a notice of such meeting in two newspapers of general circulation within the School District, four (4) times within the seven (7) weeks next preceding such School District meeting, the first publication to be at least forty-five (45) days prior to the date of the meeting.

BE IT FURTHER RESOLVED, that this resolution takes effect immediately upon its adoption.
